Northern States Power Firm Dividend Reduced

The board of directors of the Northern States Power company, Delaware, today declared a dividend of \$1.31 1/2 per share of seven percent cumulative preferred stock and a dividend of \$1.12 1/2 per share of the six percent cumulative preferred stock, both payable July 20 to stockholders of record June 30. This represents a dividend reduction of 25 percent.

The board also passed a resolution directing that a letter be sent to all registered holders of both issues of preferred stock explaining the necessity for the reduction, according to a statement of R. F. Pack, president.

58 Defendants Remain In Harlan County Case

London, Ky., June 17 (UP)—Death, illness and technical points of law had reduced the number of defendants in the Harlan coal conspiracy trial today from 69 to 58.

On Monday the remaining 58 have their day in court as the trial goes into its sixth week. Those still on trial consist of 17 coal corporations, 19 mine executives and 22 former peace officers of Harlan county.

Instruction in Music Aids Many Asylum Patients

Roseltha Nesheim Develops Orchestra as New Medium for Treatment of Insane.

Patients in the Fergus Falls hospital for the insane developed an orchestra which in its final concert this spring, presented such numbers as the William Tell overture. Through the medium of music as a supplement to general good care, several have left the hospital declared cured.

Miss Roseltha Nesheim of Moorhead, who has been directing musical work at the hospital for the past two years, discovered that many of the patients owned instruments and were willing and eager after the first few times, to receive instruction. Many of them have shown talent which has been buried since their illness, gradually returning under supervision. The orchestra was named Little Symphony and presented three concerts during the winter and spring, giving up activities during the summer. Miss Nesheim also teaches art and music in Battle Lake, Underwood and Breckenridge.
